Updating the By-Laws – Graham Forder: Graham summarized the draft By-Law revisions process re amendment affecting membership procedures, etc. Changes to be phased in order to simplify Membership Approval are as follows:

Phase 1 (approved at April Meeting):

- Directors and Officers elected for two years (not one)
- Remove two signature requirement on Treasurer
- Membership Chair authorized to collect entrance fees (not Registrar)
- Added flexibility for President regarding setting meeting dates

Phase 2 (brought to July Meeting) -Summary of revised Article II Section 2 (Membership Classes):

- Senior Member and Senior Joint – Member(s) must have at least 12 months regular/joint membership before applying (Bev Leve).
- Child – deleted because it adds no value since any child is eligible to come to a Club event (at child rates). (Ann Meneguzzi).
- Family – deleted for simplification. Family Membership is the same as Regular (or Joint) (Stefan Berlinski).
- Student upper age range extended to 26 versus 22 (Suggested by many). Students may hold office. All students must complete two activities etc. Other terms of Student membership are moved to Resolution 11.
- Life and Joint Life – no longer available to new members.
- Associate – makes it clear that the right to offset daily membership dues in up to three events against the Entrance Fee is limited to twelve months from the first event. (Bev Leve)

Graham stated that implementation of Phase 2 will be conditioned on Board approval of Resolution 11 (already circulated). Graham then asked for comments. Various members asked questions, answers were provided.

Motion to approve Phase 2: **APPROVED** unanimously.

Treasurer's Report - Bill Mayers gives financial report (attached).

Finance Committee Report: Carroll Pearson gives finance committee report (attached).

Alpine Lodge Report: Jay Gustafson gives Alpine Lodge Report (attached)

Retreat: Bill Mayers - board to hold retreat to initial preparation of strategic plan for CAC to prepare it for its second 100 years.

Web Redesign Update – Carroll Pearson reports that new site is close to being ready to go live. Helena Troy will send email blast to members. Will go through verification process to make sure only members get to see members-only pages. Carroll introduces various members who are doing volunteer work.
