Fiscal year 2015 Q1 revenue was \$43K, \$1K higher compared than FY2014. Alpine Lodge was higher \$3K. Echo Lodge was lower (\$2K). CAC was higher by \$2K due to higher donations \$10K and lower dues collections (\$8K).

Expenses

Operating expenses were higher by \$1K from last year at \$35K. Insurance premiums paid in Q1 were \$17K, nearly 50% of the total.
