## **Reports/Discussion**

With the increase those hosts will have use of inventory but must take inventory before they leave.

**Alpine Lodge Report**- Barbara Hills reported on the responsibilities distributed to the Trustees. Tom Coleman will be the lead trustee. Discussion was held on an impending new keys and locks procedures. Board is interested in having the new locks and procedures in place soon.

Outings Committee – Renee Hamilton and Ruth Tretbar are taking over for Bob Hanson and started planning last August. Dates for events are in the latest Trails. Some details still be worked on for pricing. Discussion held about surcharge for non-members attending as associate members.
