CAC Foundation Report for 2017

In 2017, the CAC Foundation gave out 11 grants totaling \$14,915. Details on our web page. The following organizations received grants:

At the end of 2017, we offered a matching grant of \$3,000 and raised \$2,850. Twenty members gave \$1,855 plus one gave \$1,000 anonymously. Names are listed in February Trails. Our total from this effort: \$5,700.

For the first time, we reached out to lifetime members who do not see our request for donations that go out with membership renewals. Response was 58 members gave \$2957.

Each year, Karen and Jerry Wagner raise funds with the Birding/ Conservation event at Echo summit, generously donated by the trustees: :\$1,500.

Donations with membership renewals brought in \$2,580.

We are seeking a new board member (maybe more) and have had several members express interest. We expect to make a decision in the coming weeks.

ECHO SUMMIT LODGE REPORT CAC BOARD OF DIRECTORS' MEETING – JANUARY 27, 2018

- New Vacuum Cleaners (3) were purchased and delivered in December at a cost of \$3801—expensive Sebo machines made in Germany. They were needed to protect our investment in the new carpeting. The new vacuums have adjustable brush height, to keep the brushes just barely touching the surface of the carpet. This was an unbudgeted expenditure.
- There are no other major projects budgeted for this fiscal year. Our financial reserves are lower than usual (\$65K) after the new carpet, vacuum cleaners, and 2nd floor mattresses. Fortunately, no large project expenses are on the horizon. Bob Henry is investigating the cost of replacing the 1" X 4" vertical trim on the shed, which is deteriorating, as well as replacement of some double-paned windows.
- We are looking for a trustee to replace our Treasurer, Richard Thornton, whose term expires April 2018. We fortunately have 2 very capable candidates.
- Serious snow is finally falling in the Sierra, with 1-2 feet of new snow. This should entice folks to fill the lodge. We hope the storm door remains open for a while now.
- Spring Work Party is scheduled for May 17-20; Host Training will be May 4-6.
- The next Echo Trustee Meeting will be Wednesday, March 14th, 2018, 5 pm, by teleconference.
