**President's report:** Jay referenced the COVID-19 Pandemic and the fact that there's a photo on the wall in Alpine Lodge of people wearing masks during the 1918/1919 Flu Epidemic. He said that it's comforting that members have been through that experience in times past - they got through it and we will thrive too!

**Vice President report**. Ann M. is the club liaison and VP of the Federation of Western Outdoor Clubs. CAC is currently renewing its membership. 2020 FWOC conference scheduled for Boise, Idaho in October. FWOC has asked Mae Harms to be interim secretary.

Amy Pertschuk director report: Working with Mark S. who will have update on membership renewals by mail later this month. This year there is a new option to renew online. Have already received 70 payments representing 160 members. Will continue to report back about online renewals. These will incur some expenses but less than \$1K per year. Not sure what payments by checks to date. Will evaluate the success of online renewals at the end of the cycle - end of May. Huge success would be 50% online renewals. Amy has hear from Bev L. who says it is extremely easy to enter new members.

**Echo Summit Lodge:** Cindy Toran said Echo is not accepting reservations until the end of April. She is looking for guidance around railings. They are in compliance with El Dorado county. Should we hold off if the insurance co. is not concerned? Steve referenced the Marin county code - fire etc. No action due. No concern by insurance.

### **Current Business**

Use of lodges during Shelter in Place; member communications and enforcement

A variety of points of view about closing/keeping the lodges open were aired. Echo has no bookings for April, Alpine does have potential activity. The question was posed as to whether we want to close the lodges to all use or to consider limited use. Issues regarding sanitation, insurance etc. (don't have coverage for pandemic) were raised as well as the need to honor the Shelter in Place orders and to have consistency in policies about the two lodges.

A motion to close the two lodges to all access until April 30th and re-evaluate via a special board call on April 16th was proposed by Jeff G. and seconded by Ann M. A board vote by individuals was requested.

The motion was passed and it was agreed that this would be communicated to trustees for immediate effect. Amy P. mentioned that it would be necessary for trustees to have access to the lodges for essential maintenance work.

# Prioritization of club event scheduling over private reservations

Donata pointed out that if there is a member event on the calendar, there is a need to honor it, however, during this outbreak and crisis, calendared or rescheduled club activities will take precedence.

#### **New Business**

**Member Volunteer Obligations:** Many functional responsibilities remain unfulfilled e.g. the events organizing chairman role and various lodge functions particularly at Alpine. Need to define job descriptions, amount of time needed and then ask members to sign up. This is how Nancy has been having success. Jim says we need Donata and Cindy to define specific lodge needs. Jay said we should have high profile work parties to relaunch the lodges when they open again.
