GENERAL INFORMATION

The California Alpine Club (CAC) is a non-profit, outdoor-oriented social club with special interests in recreation, self-reliance, and conservation. The CAC Foundation (CACF) gives annual grants to support local environmental causes in the San Francisco Bay Area and Lake Tahoe regions. Donations to CACF are tax-deductible. Year-round, CAC members organize domestic and international travel outings as well as social events and activities at our two historic lodges. Both lodges boast professional kitchens, private bedrooms, dormitory facilities, and spectacular locations. More information can be found in CAC's newsletter, TRAILS, and at californiaalpineclub.org. CAC has approximately 500 memberships and 700 members. Family memberships are encouraged.

ALPINE LODGE is located on the south slope of Mt. Tamalpais at 730 Panoramic Highway, Mill Valley, California 94941 (about a quarter mile from the Mountain Home bus stop); 415-380-8250. The lodge is available for the enjoyment of our members and their guests; it is not available for rent by the public. Every Sunday from 9am-3pm, Innkeepers host Sunday Open House, offering hospitality, refreshments (for a nominal fee), and a tour of Alpine Lodge.

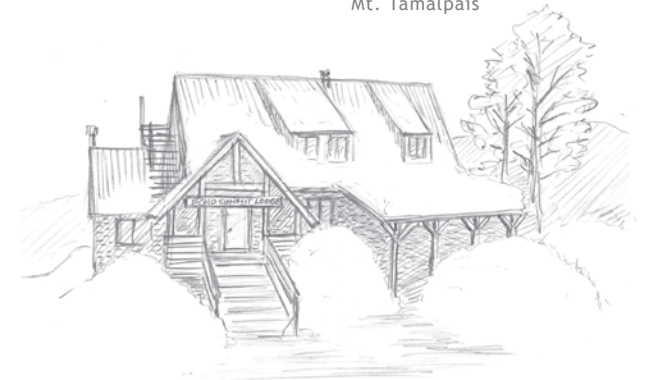
ECHO SUMMIT LODGE is perched on top of Old Meyers Grade along the south rim of the Lake Tahoe Basin on Johnson Pass Road, off U.S. Hwy 50; 530-659-7274. This year-round mountain lodge with commanding views of Lake Tahoe and the surrounding Sierra Nevada mountains sits at an elevation of 7,365 feet. The Pacific Crest Trail and the alpine lakes of Desolation Wilderness are within easy walking distance. Echo Lake, a mile from our lodge, is a delightful place in the summer to swim, fish, and boat. In winter, the area excels for ski touring, sledding, and snowshoeing. Nearby well-known downhill ski areas include Sierra at Tahoe, Heavenly, and Kirkwood.

MEMBERSHIP EXPECTATIONS

CAC lodges are maintained and operated by the membership. In order to keep our low, co-op prices, members are expected to contribute to Club operations at least once a year. Alpine Lodge holds mid-week and Sunday work parties; Echo Lodge accommodates bi-annual, multi-day "fun and work" parties. To coordinate a major Club event, host at Echo Lodge, cook a large dinner, coordinate the clean-up for Club events at Alpine Lodge, edit our TRAILS newsletter, proofread CAC documents, fill a leadership position, join a committee, or organize a wilderness hike or camp-out are just some of the other ways to satisfy this annual work obligation.

TERMS AND CONDITIONS OF MEMBERSHIP

When applying for membership in California Alpine Club, prospective members are required to:

1. Subscribe to the purposes of the CAC as stated on the front page of this form.
2. Attend at least two Club events, one of which must be a "work" activity as approved by the CAC leadership, and obtain two new-member sponsors.
3. Complete the application form in full, and READ the Dues and Entry Fee information carefully. Send completed application forms and correct fees to the Membership Chair (see information below).
4. Former members may be reinstated without an entry fee within five years of the date of membership lapse. Reinstated members do not need to attend two Club events, but still must have two current sponsors.

NEW MEMBER SPONSOR RESPONSIBILITIES

1. Explain to candidate members the purposes of the Club, how the Club operates, and how the lodges are maintained and financed.
2. Help candidate members sign up for a work party or arrange a work activity.
3. Accompany and introduce new members at their first Quarterly Meeting Lunch/Dinner. (Lunch/Dinner is complimentary for new members.)
4. Encourage new members to become active participants by helping with Club events and projects, and by assuming leadership roles.
